Letter from Leadership

As I am writing this in late October, there is hopeful anticipation that this year, for our holidays, we will be able to return to gatherings with friends and family. Somehow the jokes and memes of difficult family gatherings and crazy older relatives from prior years fade as we reach out to those we have missed and light a candle for those who are no longer with us.

COVID has changed so many things. Many are obvious, like working from home much, if not all the time, to grabbing a mask as you exit the car to enter the grocery store, to learning about the amazing intricacies and power of mRNA.

But as with all change, many things are still the same. Humans are social animals, and we need connection. Trauma and stress impact health and well-being. We have responsibilities to ourselves, and to our community.

VIM is the best of the "both/and" of this pandemic. **Our patients are working and low-income, many in front line or essential positions with no safety net. They could not work from home.** Before the vaccine was available, many of them were infected with COVID. Our clinical team prioritized access to testing, supportive health assessments and monitoring, and providing as many face masks, thermometers, pulse oximeters and hand sanitizer as we could.

When vaccines became available our clinic staff pivoted again and dedicated support to the mass vaccination clinic in partnership with Deschutes County. As soon as possible, we began offering vaccinations at our clinic for our volunteers, patients, and their families, and we will continue to offer vaccinations whenever possible.

This year as we approach the holidays, we will be especially grateful for the people in our lives who mean so much to us. On that list are the courageous patients we care for, the generous volunteers who give of their time, the colleagues we cherish and work with every day, our families who support and care for us, and our community that shows how much it cares for others through support of the VIM clinic. Together, we do extraordinary things.

Some of the amazing highlights from the last fiscal year include the **66 new volunteers** who reached out to join us this year, and **the 1,922 prescriptions valued at \$1,346,321** that we filled without pause. **Of the 231 VIM patients that were tested for COVID, our staff followed up with the 85 that tested positive,** to make sure patients had groceries and medicines while they were isolating.

Looking ahead we are hopeful and confident that we will have another important year, that we will continue to make a difference in the lives we touch. If our work inspires you, we hope that you will join us—as a volunteer, on our board,



as an ambassador telling others about the clinic, or as a donor. It is only through you that we can continue our mission "To improve the health and wellness of the medically uninsured or critically underserved through the engagement of professionals, community partners, and dedicated volunteers."

Seeing the Need for Care

Dr. Mathews' history in Central Oregon dates back to the 1960s, when he was a ski racing kid with friends in Bend. Some of those kid's parents later became his patients, but still viewed him as that same kid, which he thinks is great!

Dr. Mathews practiced ophthalmology in Bend for thirty-three years and remembered hearing about VIM when it opened. VIM remained on the periphery of his awareness as he would occasionally see patients referred to him from VIM. And he heard




about it from a friend of his, Dr. Stan Shepardson, who has been volunteering at VIM since the clinic opened.



Barriers, Burdens & A Better Life

Emilio and Laura are not only from the same city in Mexico, they grew up on the same street. Laura says, "We've known each other since we were children. When we were 19, we started seeing each other." They later married and started a family, but the financial constraints they faced seemed insurmountable. Emilio had family in Prineville and Culver, and they agreed they could give their family a better chance by having Emilio work in the states.



Emilio has now been in Central Oregon for 18 years. He says, "The original plan was for me to come for two years, and then go back. After a year of being here, my wife wanted to come. Maybe, like many wives who are left behind in Mexico, she was afraid that I wouldn't come back. But an opportunity presented itself, and Laura and our children moved here." But coming to the states, their family faced different challenges. Emilio continues, "I really wish I was able to make a life there in my home city in Mexico. I regret moving here. The price has been very high to stay and raise a family here. Laura lost her father a few years ago, then her mother. Now my mother is ill, and I can't see her, so we're just waiting for the word of her passing.

When Laura came, she brought our two children, and we had one more here. One has grown up, married, and now we have two grandchildren age 3 and 6. What is important to Laura is her grandchildren. If we left, maybe we'd never see them again, and she'd always be wondering how they're doing. They'd be able to come to visit us there, but the distance creates obstacles. It's different when you live close by. We are anchored here."

Emilio and Laura feel anchored to their Central Oregon home for more reasons than only their family. Emilio says, "This is where the medical issues come into play. Over the years my wife became ill. Under the care of VIM, she was told they had detected a tumor on her pancreas. It was something like five years ago that she was operated on: they took out a 1/3 of her pancreas. Things changed quite a bit. Since her surgery, she got diabetes immediately. She now depends on a medicine and a treatment plan. And if this had happened in Mexico? I may not even have my wife. I'm sure Laura wouldn't have been able to get the medical attention there that she receives through VIM – and me either!

I've got high blood pressure, diabetes, and high cholesterol. Recently, VIM discovered I had sleep apnea, and they've provided me with a machine. Laura and I see a dentist through VIM. Laura suffered from other complications following her surgery. She developed blood clots in her lungs, had breathing issues. Through VIM, she got respiration therapy at home, and a doctor would check her lungs periodically. Now she's on a blood thinner for the rest of her life. I remain very grateful, especially considering that in Mexico, maybe I would not be so fortunate. There's an infinity of things the clinic has helped us with. They have helped us in every way possible."

With the help of VIM's volunteers and community partners, the care provided to Emilio and Laura continues. They're now in VIM's Diabetes Wellness Program, offering lessons in nutrition and medication for diabetics. Laura shares her experience: **"We have appointments with VIM's diabetic educator. I don't have anyone to leave my daughter with when we go to those appointments, so she comes with us - she's learning more about healthy eating too.** We all follow the diet that is recommended: eat healthier, eat more vegetables...but" Laura adds with a laugh, "...they lose weight and I don't!"

When asked how they feel about the clinic, Laura said, "Everything has been excellent at VIM. They treat me marvelously every time I go. They show a lot of concern for me. Everyone attends to us very well. **During my illness**, **Dr. Letovsky (VIM's Medical Director) always attended to me. He always calms me, and I always leave the clinic very, very happy**." Emilio adds, "I really appreciate that VIM has clinic hours on Tuesdays in the afternoon and evening. I mean, where can you go to see a doctor at 6 or 7 in the evening?! Other than in special cases, I haven't had to miss work in order to go to the clinic, and that is really important for me. Everyone at VIM is really kind. I am more than grateful to VIM. If you want to hear more stories, I've got lots more!"

# Patient Summaries

Salena is in her mid-50s. She lives with her spouse and mother in Redmond where the family receives income from the construction industry. VIM provides care for asthma, hypertension, history of rheumatic fever, history of kidney stones. Over the past year she had three provider visits, one lab draw, and three prescription medications.

Marco is in his mid-70s and lives with his wife, daughter, son-in-law, grandson, and granddaughter in Bend. The family's income is from landscaping and restaurant industries. VIM has provided care for CVA with right-sided hemiparesis, stable abdominal aneurysm, BPH with urinary obstruction, renal insufficiency, high cholesterol, and


hypothyroidism. Over the past year he has had 16 nurse visits, 1 flu shot, 2 lab tests and has been prescribed 8 medications.

Victoria is in her late 40s, lives alone in Bend and works in the janitorial industry. VIM provides care for pre-diabetes. She had one lab draw, three provider visits, one community partner referral to Orthopedics for knee and hip pain as well as imaging: pelvic ultrasound, and mammogram.

14 Years of Service: Building a Cultural Bridge

Carlos was born and raised in the largest seaport in South America: Santos, Brazil. He started his US journey in New York City before moving to the San Francisco Bay Area, where he was part of the Summer of Love in 1967. Carlos received his degree from San Francisco City College in hotel and restaurant management, which led to a career in the retail food business. Carlos and his wife, Gwenn, moved to Bend fifteen years ago, when they came looking for a co-housing community called Higher Ground. They stayed because of the overall kindness of Bend, the great health care, and all the accessible outdoor opportunities.

Shortly after arriving in Bend in 2007, Carlos made the acquaintance of one of VIM's first medical directors, Dr. Charlie Ayers. **Carlos decided to join the team and was added to the Monday schedule, which he stuck to throughout the fourteen years of his volunteer service.** 



Being a Spanish interpreter at VIM was a point of pride for Carlos, where he made a many lifelong friends and developed a deeper understanding and appreciation for nonprofits and volunteers. **He came to understand that in his role as an interpreter, he was also a cultural bridge for many of the patients and staff.** Carlos ended his volunteer service with VIM this November and the VIM board, staff and Carlos' fellow volunteers wish him well. He loved being a part of the collaboration between doctors, nurses, staff, and patients that provided a comprehensive service that truly made our community a stronger and healthier place.
