Dear Friends and Supporters,

What does hope look like in Central Oregon?

For Wyatt, a father recently diagnosed with Multiple Sclerosis, hope is the ability to work and provide for his young daughters. Before finding us, the high cost of his specialized care felt insurmountable. Today, because of VIM Cascades, Wyatt has hope and remains employed, receiving comprehensive care from our volunteer-led clinic and pro-bono partners.

For over twenty years, VIM Cascades has operated on a powerful belief: healthcare is a human right. No one should have to choose between their health and their basic needs.

Our patients are the heart of our community: construction workers, the hospitality sector, groundskeepers, retail workers, and small business owners. They come to VIM Cascades for a hand up, not a handout. People like Maria, a self-employed seamstress, who relies on our clinic and charitable pharmacy to manage her diabetes so she can run her business.

Thanks to thousands of dedicated volunteers, we have served more than 16,000 uninsured working people since 2004, delivering over \$212 million in community benefit. VIM Cascades is also home to Oregon's only charitable pharmacy east of the Cascades, providing over \$2 million annually in life-saving medications at no cost.

Yet, even as we celebrate this legacy of care, we must sound an alarm. Healthcare is in the headlines. The Affordable Care Act's premium tax credits are set to expire in December 2025. Without them, millions of Americans, including thousands right here in Central Oregon, will see their health insurance premiums more than double on average.

It's likely someone you know is facing this reality right now. Your support today is more critical than ever. We are prepared for a surge in need, and your donation is a direct investment in our community's health, ensuring our doors stay open for the people who need our help.

The founders of VIM Cascades built this clinic on a foundation of vision and courage. Today, we ask you to help us meet the challenges ahead.
